NOTICE INVITING TENDER

THE EXECUTIVE ENGINEER, SANGRAM DIVISION, PWD AP invites on behalf of Governor of Arunachal Pradesh Item Rate Contract Single Stage Bidding Process under Two Cover System (Both Technical bid and Financial bid) from eligible bidders of appropriate class as per conditions laid in Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act, 2015 for the execution of work as detailed in table below.

The Tender form and other details can be obtained from the office of the Executive Engineer, Sangram Division, PWD AP, Sangram on submission of application for tender form and payment of non refundable Rs. 3000.00 (Rupees Three Thousand) w.e.f 4/5/2021. The last date of receipt of application to purchase tender form will be 6/5/2021 at 4.00 pm.

Intending bidder should produce following original documents before tender form issuing authority and the attested copy of same document should be enclosed along with the application to purchase tender form :-

1. Valid firm registration
2. Permanent Residential Certificate (PRC)
3. Schedule Tribe Certificate (ST)

Note: Detail information of the work and conditions of contract may be seen in the tender document. The completion period for execution of work is 6 (six) months. Payment will be done according to phasing and release of fund.

1. Tender documents can be purchased from the office of the Executive Engineer, Sangram Division, PWD AP, Sangram, on all working days by submitting application along with requisite certificates/documents and on payment of Cost of Tender Paper in cash (non-refundable) w.e.f 4/5/2021. Receipt of application for issue of forms shall be up to 4.00 PM on 6/5/2021.
2. Tender paper shall be received up to 1.30 PM on 10/5/2021 at the office of the Executive Engineer, Sangram Division, PWD AP, Sangram and shall be opened on the same day at 2.00 PM in presence of intending contractors or their authorized representatives.

3. The Original Copy of Earnest Money Deposit as specified in Clause 9 to 9.1 of NIT (CPWD Form-6) of bid document in favor of the Executive Engineer, Sangram Division, PWD AP, Sangram, shall be enclosed with the tender document in separate sealed envelope.
4. Eligibility Criteria: The participants must have successfully executed three similar works each of value **40%** of the estimated cost or two similar works each of value **60%** of the estimated cost or one similar work of value **80%** in Central/State Govt. organizations/PSU's during last five years.
5. The Participants must submit proof of possessing T & P as which are likely to be used in carrying out the work as required under SCHEDULE – F of the tender document failing which the tender shall be rejected by employer as Non Responsive.
6. The intending Firms/Contractors shall furnish a No Due Certificate (NDC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after 31/12/2019 by the Managing Director Cum Chief Executive Officer, Naharlagun. No tender paper shall be issued to any intending bidder without submission of aforesaid certificate from Arunachal Pradesh State Co-Operative Apex Bank Limited.
7. The Arunachal Pradesh District Based Entrepreneurs Professionals, Incentive, Development & Promotional Act 2015 shall be applicable in this tender.
8. The Earnest Money Deposit (EMD) from APST contractors shall be accepted as per Government Order No. SPWD/W-182/2013(pt)/ dated 06/07/2015 on production/ submission of valid document in original as proof of his/her being as APST Contractor.
9. The Tender without Earnest Money in proper form shall be summarily rejected.
10. The competent authority reserves the right to reject any or all the Tender without assigning any reason.
11. The bidder has to submit an affidavit regarding litigation and the competent authority reserves the right to reject the bid if the bidder found to be in litigation as and when detected without assigning any reason.
12. The Eligibility of Contractor shall be as per conditions laid down in Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act, 2015 published in Arunachal Pradesh Gazette Vide No. 224 Volume XXII Naharlagun 11th September 2015.
