THE EXECUTIVE ENGINEER, RAGA DIVISION, PWD AP, invites on behalf of Governor of Arunachal Pradesh Item Rate Tender Single Stage Bidding Process under One Cover System (Both Technical Bid and Financial Bid) from eligible bidders of appropriate class as per conditions laid down in Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act, 2015 with up to date amendments for the execution of work as indicated in the table below.

 - Permanent Residential Certificate (PRC) of Domiciled under Kamle District.
 - An Affidavit Not Engaged in more than 2 (two) Works in hand.

The Tender form and other details can be obtained from the office of the **Assistant Engineer, Muri Mugli Sub Division, PWD AP, Murimugli** on all working days by submitting application along with requisite certificates/document as specified at para 2 above and on payment of non-refundable ₹ 2000.00 (Rupees Two thousand) w.e.f. 27/06/2023. The last date of receipt of application to purchase tender form will be 30/06/2023 at 1400 hours. The last date of issue of tender paper shall be 30/06/2023 at 1400 hours
5. Tender paper shall be received up to 1330 Hours on 05/07/2023 at the office of the **Assistant Engineer, Muri Mugli Sub Division, PWD AP, Murimugli** and shall be opened on the same day at 1400 Hours in presence of intending contractors or their authorized representatives.
6. The Original Copy of Earnest Money Deposit as specified in Clause 9. to 9.4 of NIT (CPWD Form-6) of bid document in favor of the Executive Engineer, Raga Division, PWD AP, Raga, shall be enclosed with the tender document in separate sealed envelope.

7. Eligibility Criteria: The participants must have successfully executed three similar works each of value 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% in Central/State Govt. organizations/PSU's during last five years.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of application for tender.

8. The Participants must submit proof of qualification, experience, age address etc. of the technical personnel likely to be deployed in the project & proof of possessing T & Ps as which are likely to be used in carrying out the work as required under SCHEDULE -F of the tender document failing which the tender shall be rejected by employer as non-Responsive.
9. The intending Firms/Contractors shall furnish a No Due Certificate (NDC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued by the Managing Director Cum Chief Executive Officer, Naharlagun (Should be valid till last date of submission of bids)
10. The Earnest Money Deposit (EMD) from APST contractors shall be accepted as per Government Order No. SPWD/W-182/2013 (pt)/ dated 06/07/2015 on production/ submission of valid document in original as proof of his/her being as APST Contractor.
11. The Tender without Earnest Money in proper form shall be summarily rejected.
12. The competent authority reserves the right to reject any or all the Tender without assigning any reason.
13. The bidder has to submit an undertaking regarding no litigation history and the competent authority reserves the right to reject the bid if the bidder found to be in litigation as and when detected without assigning any reason.
14. The Eligibility of Contractor shall be as per conditions laid down in Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act, 2015 with up-to-date correction slips/amendments.
