He shall also eligible for participation in any tender is required to submit completion certificate issued by the Engineer-in charge duly countersigned by the concerned Superintending Engineer and Chief Engineer.

## CRITERIA OF ELIGIBILITY FOR APPWD AS WELL AS NON- APPWD CONTRACTORS.

- (1) Three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 60% of estimated cost or one similar work of value not less than 80% of estimated cost (rounded to nearest Rs. 10 lakh) in last 7 years ending previous day of last date of submission of bids.
- (2) The value or executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the dated of completion to the last date of completion to the last date of receipt of applications for tender.
- (3) The contractor should have experience of bridge "Construction of Steel Bridge of span not less than 90.00m".
- (4) For the purpose of this clause 'similar work' means the works of Construction of Steel bridges of span not Less than 90.00m and Construction of Road.
- (5)Solvency Certificate or Net worth Certificate: Solvency of the amount equal to 40% of the estimated cost put to the tender (ECPT)

Net worth certificate of minimum 10% of the estimated cost put to tender issued by certified Chartered Accountant.

- (6) Any agency involved / engaged in litigation / arbitration with the Department at present or blacklisted with any Govt. / Autonomous organization are discouraged and disqualified from participation in this tender. In the event of such disclosure at later stage even after acceptance / award of work, shall automatically lead to termination of contract including forfeiture of earnest money including security deposit.
