
The Executive Engineer, Daporijo Division, PWD, AP, Daporijo invites bids/tenders on behalf of the Governor of Arunachal Pradesh for execution of works on Turnkey basis from experienced and competent contractors as detailed below. The interested bidders are advised to examine carefully all instructions including addenda/amendments to ITB, Conditions of Contract Data, Technical Specifications, Bill of Quantities, various forms, Terms and conditions, etc in the Bid/Tender Document.

Bidding documents (and additional copies) may be purchased from the office of the Executive Engineer, Daporijo PWD, Division Daporijo from 09/03/2015 to 14/03/2015 for a non refundable fee as indicated, in the table above, in form of Deposit at Call Receipt for Fixed Deposit Receipt (FDR) of a scheduled bank guaranteed by Reserve Bank of India payable at State Bank of India, Daporijo in favour of the Executive Engineer, Daporijo P.W Division. The Bidding document requested by mail will be dispatched by registered/speed post on payment of an extra amount Rs 1500.00. The department will not be held responsible for the postal delays, if any, in the delivery of the documents or non-receipt of the same.
2. Bids must be accompanied by Bid security/Earnest Money of the amount specified for the work in the table above, payable at State Bank of India, Daporijo drawn in favour of Executive Engineer, Daporijo, and P.W Division, as the case may be. Bid security/Earnest Money will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
3. Bids under two separate sealed covers for individual packages super scribed as "Technical Bid" and "Financial Bid" must be delivered to the Executive Engineer, Daporijo PW Division, on working days and latest by 1500 hrs on or before 18/03/2015. The "Technical Bid" will be opened on the same day at 1530 hrs. by the Executive Engineer, Daporijo PWD Division or an authorized representative of the Executive Engineer, PWD Daporijo Division, in the presence of bidder(s) or authorized representative of the bidder(s). who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. "Technical Bids" shall be evaluated by a screening/evaluation committee at the Division/Circle Zonal office whose decision shall be final as the case may be, and the bidder(s) who qualify shall be invited to attend the opening of "Financial Bids" for which the date and venue will be intimated later on.

  - i) After the work is awarded, it will be the responsibility of the Contractor to develop architectural drawings, to do the detail structural design and drawings.
  - ii) The architectural drawings development by the Contractor shall be got approved by the client department through PWD.
  - iii) Detail Sub-Soil investigation and any of other required surveys and tests will invariably precede the structural design and the development of the structural drawings. In other words, the structural design and the development of the structural drawings will strictly be based on the findings of the sub-soil investigation and any of other required surveys and tests.
  - iv) The Contractor will get the structural design and the structural drawing so developed, proof-checked by a IITs/NITs or any government institute of repute. The BOQ (Bill of Quantities) indicating individual items and the cost estimation should be prepared based on the proof-checked structural drawings.
  - v) The Contractor shall prepare the BOQ (Bill of Quantities) indicating individual items and cost estimation within their bid amount based on the proof-checked structural drawings.
  - vi) Nothing additional shall be paid to the contractor for development of architectural drawings, sub- soil investigation and any of other surveys and tests, structural design, development of structural drawings and getting them proof-cheeked by any of the government institute. The total project cost shall be inclusive of expenses on all these activities. Further clarifications, if needed, on this issue may be had by personal enquiries during purchase of the Bidding Document.
5. The employer reserves the right to accept or reject any bid, and to cancel the entire bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the Employer's action.
6. A pre-bid meeting will be held on 06/03/2015 at 1100 hrs in the office of the Superintending Engineer, Basar Circle PWD, AP, to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidders" of the document.
7. The bidder will have to submit a No Dues certificate (NDC)/No. Objection Certificate (NOC) from the Arunachal Pradesh state Co-operative Apex Bank Limited, not older than three (3) months duly issued by the Managing Director Cum Chief Executive Officer, Itanagar along with the bid.
8. Other details and other documents to be submitted will be as described in the Bidding Document.
9. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
10. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
11. The information/documents mentioned in (8), (9) and (10) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section (s) of the Bidding Document. The guarantees, certificates, etc from bank (s) and other authorities and other information shall be furnished as per the standard forms given in the relevant section (s) of the Bidding Document.


