The Executive Engineer, Yazali Division, PWD, AP, Yazali on behalf of the Governor of Arunachal Pradesh, invites sealed Item Rate Tender in single bidding process from eligible and registered contractors under APPWD on appropriate class and domiciled within the territorial jurisdiction of Assembly constituency based on District Based Entrepreneurs and professionals (incentives, development and promotional) (amendment) Act No. 7 of 2020.

 - ii) The participants must have successfully executed in Central/State Govt./PSU's three similar works each of value of 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value of 80% of the estimate cost during last five years.
2. Tender papers will be issued to eligible contractors on production of definite proof from the appropriate authority.
 3. Tender paper can be purchased from the office of the Executive Engineer Yazali Division PWD AP Yazali on all working days by submitting application and on payment of cost of Tender paper in Cash (non-refundable) from **24-02-2024 to 29-02-2024 (up to 1430.00 hrs.)**. Tender Document requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of **Rs.1500.00**. the department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
 4. Tender must be delivered to Executive Engineer Yazali Division PWD AP Yazali on or before **1430.00 hrs** on **01-03-2024**. The tender will be opened on the same at **1500 hrs** in the office of the Executive Engineer Yazali Division PWD AP Yazali by him or his authorized representative in the presence of intending tenderers.
 5. The earnest money of the amount specified above in the form of ~~Demand Draft/Banker Cheque~~ Fixed Deposit Receipt/Term Deposit Receipt in favour of Executive Engineer Yazali Division PWD AP Yazali should be enclosed with the Tender Document in separate sealed cover.

6. The intending firms /Contractors should furnish the No Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh Co-Operative Apex Bank Limited duly issued on or after 01-01-2024 by the Managing Director Cum Chief Executive Officer. No Tender Paper shall be issued to any intending bidder without submission of NOC from Arunachal Pradesh State Co-Operative Apex Bank Limited.
7. The intending firms/Contractor should submit Income Tax clearance Certificate for last one years or Income Tax Exemption Certificate as the case may be.
8. Other Document/ Information required to be furnished by the tenderers are described in the Tender Documents.
9. Bidders are advised to inspect the site and its surrounding and satisfy themselves before submitting their Tenders.
10. The competent authority reserved the right to reject any or all the Tender without assigning any reason.
11. The tender without earnest money in proper form shall be summarily rejected.
12. The payment shall be made as per allocation of fund according to year wise phasing. The Department shall not be held responsible for delay in payment in case of non-release of fund by the Govt. as per phasing.
13. The APST contractors shall submit ST Certificate to avail relaxation of Earnest Money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of ST Certificate.
14. Affidavit stating that bidder is not having more the 2 (two) works in hand should be submitted.
15. The letter of acceptance shall be issued only after getting finance concurrence from finance and Planning Department Govt. of A.P.
