1.7. Eligibility Criteria

1.7.1. Enlistment Status:

- (i). Bidder should be either enlisted with any of the Enlistment Authority & shall be governed in accordance with provisions as per Arunachal Pradesh District Based Entrepreneurs and Professionals Incentives, Development & and Promotional) Act of 2020 vide Notification No. Law/Legn-23/2020 Dtd. 02/11/2020 as under:
 - (a) Class 1 Civil category enlisted contractors/firms under Arunachal Pradesh Public Works Department (APPWD), or
 - (b) Equivalent class/category registered with other Govt/Autonomous organizations (State PWD, CPWD,

BRO, NHAI, NHIDCL, BRO etc.) involved in Bridge projects.

- (c) For 'Equivalent class/category' Bidders eligible to bid above ₹20.00 (Rupees Twenty Crore) shall be considered.
- (ii). Joint Ventures (JV) are not allowed.
- (iii). PoA (Power of Attorney) Holders representing any firm / entity are barred from participating in this Bid. Only Proprietor or Managing Director of Firm/Company are eligible.
- (iv). The enlistment/ registration of the firm must be valid on the scheduled date of opening of Technical Bid prescribed at Table-Para 1.5

1.7.2. Similar Nature of Works:

- (i) The bidder should have satisfactorily completed the one work as mentioned below during the last 7 (seven) years ending previous day of last date of submission of tenders:
 - (a) 3 (three) similar works each of value not less than ₹11.98 Crore (40% of estimated cost put to tender) or 2 (two) similar works each value not less than ₹17.97 Crore (60% of estimated cost put to tender) or 1 (one) work of value not less than ₹23.96 Crore (80% of estimated cost put to tender).
- (b) One completed work costing not less than ₹599.00 Crore (20% of ECPT) crore executed with EPC mode contract during the last 7 years ending last day of the month previous to the one in which tenders are invited. This work can be part of eligible work at 1(a) above or as a separate work.

For this purpose, a project shall be considered to be completed, if more than 90% of the value of work has been completed, and such completed value of work is equal to or more than 20% of the estimated project cost.

- (ii) The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of submission of bid.
- (iii) For the purpose of this clause 'similar work' means the works of "Construction of RCC/PSC/Composite Bridge conforming 30R Loading specification".

(iv) Completion certificate with the correspondence address/e-mail id / contact no. of issuing authority (in the rank of EE or equivalent) must be uploaded while participating in the tender)

1.7.3. Financial Soundness:

- (i) The bidder should have average annual financial turn-over (gross) of not less than ₹14.98 crore (fourteen crore fifty four lakh) [50% of estimated cost put to tender (ECPT)] on civil construction works during the last available three years balance sheets duly audited by Chartered Accountant.
- (ii) The bidder should not have incurred any loss in more than two years during the last five years as per balance sheets duly audited by Chartered Accountant.
- (iii) The bidding capacity of bidder shall be equal to or more than the ECPT of ₹29.95 Crore.
- (iv) The bidder shall submit Solvency/Bankers Certificate of minimum 40% (₹11.98 Crore) of the ECPT OR Net worth certificate of minimum 10% (₹2.99 Crore) of the ECPT issued by certified Chartered Accountant.
- (v) The bidder shall submit Credit facility from Bankers 10% of ECPT.
- (vi) The bidder shall submit an affidavit to invest cash up to 25% of ECPT).
