

EXECUTIVE ORDER

WHEREAS, under the National Highway Development Programme of the Ministry of Shipping Road, Transport and Highways, the Government of India is proposing to connect Itanagar, the State Capital of Arunachal Pradesh by a 4-laned Highway, running from Banderdewa to Hollongi via Karsingsa, Nirjuli, Naharlagun, Papu Nallah and Itanagar,

AND

WHEREAS, the Department of APPWD would be the Executive Agency of the Programme.

AND

WHEREAS, the APPWD would be in need of adequate land along the alignment of NH 52-A from Banderdewa to Holongi for the propose 4-laned Highway

AND

WHEREAS, the proposed 4-laned Highway will require 60 mtrs wide in open area and about 40 mtrs in built up areas or more

AND

WHEREAS, the Government is proposing to acquire the required land by issuing a notification, proclaiming the intent of the State Government to acquire the land for 4-laned Highway.

I therefore, Shri Bidol Tayeng, Deputy Commissioner-cum-District Magistrate under Section 133 CrPC hereby order immediate stoppage of any construction activities within the specific land width along the alignment of the proposed Highway from Banderdewa to Holongi with immediate effect.
