Eligibility Criteria: The participants must have successfully executed in Central/State Govt./PSU's three similar works each of value 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% of the estimated cost during last five years. However, this condition is not applicable for Class V.
2. The participants must submit proof of possessing T&Ps as required under SCHEDULE-"F" of the tender document without which tender shall be rejected except Class V.
3. The participants must submit proof of having technical personnel's with proof of qualification, experience, age, address etc. as required under SCHEDULE – "F" of the tender document without which the tender shall be rejected.
4. Tender paper can be purchased from the **Executive Engineer, Daporijo Division PWD, A.P, Daporijo** on all working days by submitting Application along with requisite experience certificate and on payment of Cost of Tender Paper in cash (non-refundable) from **12/03/2019 to 13/03/2019** (up to 1600 hrs). Tender Document requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of **Rs. 500.00**. The department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.

5. Tender must be delivered to the Executive Engineer, Daporijo Division PWD, AP, Daporijo on or before 18/03/2019 Hours on 1200 Hours. The Tender will be opened on the same day at 1230 Hour in his office by him or his authorized representative in presence of intending tenderers.
6. The Earnest Money of the amount specified above in the form of Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, Daporijo Division, PWD, Daporijo should be enclosed with the Tender document in separate sealed cover.
7. The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after 28/02/2019 by the Managing Director Cum Chief Executive Officer, Naharlagun. No Tender Paper shall be issued to any intending bidder without submission of NDC from Arunachal Pradesh State Co-Operative Apex Bank Limited.
8. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case maybe.
9. The intending Firms/Contractor should submit GST registration.
10. Other document/information required to be furnished by the tenderers are described in the Tender documents.
11. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their tenders.
12. The competent authority reserved the right to reject any or all the Tender without assigning any reason
13. The Tender without earnest money in proper form shall be summarily rejected.
14. The APST contractors shall submit ST Certificate to avail relaxation of Earnest Money in favour of them. Original PRC and ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of PRC and ST Certificate.
15. The Arunachal Pradesh District Based Entrepreneurs, Professionals, incentives, Developments & promotional Act 2015 shall be applicable in this Tender.
