Please refer to the State Planning Department's letter No.PD(NLP)05/2008 dated 23.12.2008 submitting Detailed Project Report (DPR) of the project proposal "Construction of road from Magopam to Bichom via Namfri (50 Km) via Ditching, Sacheda, Ramu-Sotu and Lichini under Singchung sub-division" in Arunachal Pradesh at Rs.15.98 crore under Non-lapsable Central Pool of Resources (NLCPR).

- 2. The context and background of the project given in the DPR does not give details of road specifications like proposed road width and carriage way width, etc. In the proposal it is proposed to construct only first 15 Kms (Phase-I) of the road starting from Magopam. However, the name of the termination point (i.e. 15<sup>th</sup> Km) has not been mentioned.
- 3. Please inform the detailed specifications of the proposed road i.e. formation width and carriage way width etc. and also the name of the termination point of the project at the earliest to this Ministry for further necessary action.
