Bids under two separate sealed covers for individual packages super scribed as "Technical Bid" and "Financial Bid" must be delivered to the Chief Engineer, Eastern Zone, PWD, AP, Division, on working days and latest by 1500 hrs on or before 25/03/2010. The "Technical Bid" will be opened on the same day at 1530 hrs in the presence of bidder(s) who wish to attend or authorized representative of the bidder(s).
