EXECUTIVE ORDER

WHEREAS, the Ministry of the Shipping, Road Transport & Highways, the Government of India has notified NH-229, starting from Tawang passing through Nechipu, Seppa, Sagalee, Kheel, Hoj, Ziro, Daporijo, Bame, Aalo, Pangin and terminating at Pasighat; NH-52 B, starting from Mahadevpur, passing through Namchik, Manmao, Changlang, Khonsa, Longding & Kanubari and Extension of NH-37, extended from its dead end near Saikhowaghat in Assam to join NH-52 near Roing (Meka), notified vide No. S.O. 1163 (E) published on 16/05/2008 in part II, Section 3, Sub-section (ii) in the Gazette of India, Extraordinary

AND

WHEREAS, the Ministry of the Shipping, Road Transport & Highways, the Government of India intends to implement the project through agencies like Boarder Roads Organization and Public Works Department, Arunachal Pradesh for the proposed 2-laned Highway.

AND

WHEREAS, the implementing agencies would be in need of adequate land along the alignment of NH-229, NH-52 B and NH-37 (Extension) for the proposed 2-laned Highway.

AND

WHEREAS, proposed 2-laned Highway will require 45 metre wide in open as well as built-up areas or more.


AND

WHEREAS, the Government is proposing to acquire the required land by issuing Notification, proclaiming the intent of the State Government to acquire the land for 2-laned Highway.

Proposed Road under NH-52-B

- 1) Changlang-Khonsa road 41.00 Km (Under Khonsa PWD Division)
- 2) Road from Khonsa-Tissa-Longding-Kanubari (127.48 Km)

THEREFORE, I Ankur Garg, Deputy Commissioner –cum-District Magistrate under Section 133 CrPC hereby order immediate stoppage of any construction activities within the specific land width along the alignment of the proposed Highway all along the 52 B under Tirap District with immediate effect.


