EXECUTIVE ORDER

WHEREAS, Ministry of Shipping, Road Transport & Highways (Department of Road Transport and Highways), Government of India, has notified NH-229, starting from Tawang passing through Nechipu, Seppa, Sagalee, Kheel, Hoj, Ziro, Daporijio, Barne, Aalong, Pangin and terminating at Pasighat and, further starting from Extension of NH-52 B near Mahadevpur, passing through Namchik, Manmao, Changlang, Khonsa, Longding and Kanubari and Extension of NH-37, extended from its dead end near Saikhowaghat in Assam to join NH-52 near Roing (Meka), vide No, S.O.1163 (E) and published on 16/05/08 in part IL Section 3. Sub-Section (ii) in the Gazette of India Extraordinary;

AND WHEREAS, Ministry of Shipping, Road Transport & Highways, Government of India, intends to implement the project through agencies like Border Roads Organization and Public Works Department, Arunachal Pradesh for execution of the National Highway;

AND WHEREAS, the implementing agencies would be in need of adequate land along the alignment of NH-229 for widening it to National Highway specifications which will require 45 metres width in open and 20-30 metres in built — up areas;

AND WHEREAS, the Government is proposing to acquire the required land by issuing notification, proclaiming the intent of the State Government to acquire the land for the said National Highway;

Therefore, I, Shri Rajeev Takuk, Deputy Commissioner-cum-District Magistrate, under Section 133 CrPC, do hereby order immediate stoppage of any construction activities from East Siang-West Siang inter-district boundary near Tarak to Pangin (Sangam tri-junction) thence to Pasighat (Raneghat NH 52 tri-junction point of Pasighat -Pangin Road), within the specified land width along the alignment/places of the proposed NH-229 with immediate effect.
